This has reference to your application dated 31st October, 2002, for affiliation of a new college for Education (B.Ed.) proposed to be started at Oshiwara, Jogeshwari, Mumbai-400 102 from the academic year 2003-04.

In this connection, I am directed to inform you that considering the permission granted by the Government of Maharashtra to your Society as per the letter referred above, the Ag. Vice-Chancellor under the powers conferred upon him under Section 14(7) of the Maharashtra Universities Act, 1994 has granted the permission for first time affiliation to your Society to open a new college of Education (B.Ed.) at Oshiwara, Jogeshwari (West), Mumbai, on permanently 'No Grant Basis' from the academic year 2004-05 to start the B.Ed. Degree Course with intake capacity of 100 students.

The college has to fulfill the conditions mentioned in the letter under reference, issued by the Regional Director, National Council for Teacher Education, Bhopal.

The college has also to fulfill the following affiliation conditions -

- (1) that the conditions laid down by the University from time to time.
- (2) that the minimum attendance of all the students must not be less than 75% during the academic year and college will have to complete syllabus of all the subjects during the academic year.


- (3) Admissions should not be linked with donations.
- (4) that they will strictly follow the Ordinance 2802 in respect of preventing the colleges and Management of Colleges from accepting donation or capitation fees for admission of students in the Colleges, quoted in the University Circular No.Aff./Recog./49 of 1987, dated 4th February, 1987 (copy enclosed).
